### Answer given by Mr Avramopoulos on behalf of the Commission

The Commission is regularly informed about the situation at the Spanish-Gibraltar border, including on delays reported by citizens upon entry or exit to Spain. It is committed to continue working on this matter to find a sustainable solution and improve the situation of many citizens crossing this border daily.

On 30 July 2014, the Commission addressed requests for additional measures to both Spain and the United Kingdom to be implemented without delay in order to reduce the waiting time. One of the measures requested from Spain was to optimise risk-based profiling and to adapt the checks at the border accordingly. The Commission recently received a reply from Spain and will now analyse it before assessing the situation at this border again.

### Respuesta del Sr. Avramopoulos en nombre de la Comisión

La Comisión recibe periódicamente informes sobre la situación en la frontera hispanogibraltareña, en particular sobre los retrasos señalados por los ciudadanos a la entrada o salida de España. La Comisión se ha comprometido a seguir trabajando sobre este asunto para encontrar una solución sostenible y mejorar la situación de muchos ciudadanos que han de cruzar la frontera diariamente.

El 30 de julio de 2014, la Comisión dirigió solicitudes de medidas adicionales a España y al Reino Unido para su puesta en práctica sin demora a fin de reducir el tiempo de espera. Una de las medidas solicitadas por España era la optimización de la elaboración de perfiles basados en el riesgo y la adaptación en consecuencia de los controles en la frontera. Recientemente, la Comisión ha recibido una respuesta de España y ahora la está analizando, antes de evaluar de nuevo la situación en esta frontera.
