Gobierno de Gibraltar: Ministerio de Comercio

El lanzamiento de la Asociación para las Nuevas Tecnologías de Gibraltar impulsa el pujante ecosistema blockchain del país

La Asociación comercial centrada en blockchain actuará como foro para legisladores, reguladores, empresas profesionales y educadores

Gibraltar, 30 de octubre de 2018

El Gobierno de Gibraltar ha anunciado hoy formalmente el lanzamiento de la Asociación para las Nuevas Tecnologías de Gibraltar (Gibraltar Association for New Technologies, GANT), una asociación comercial que buscará impulsar el enfoque innovador de Gibraltar hacia la Tecnología de Registros Digitales Compartidos (Distributed Ledger Technology, DLT). La asociación establecerá líneas de comunicación formal entre legisladores y el sector privado en el pujante sector blockchain gibraltareño, además de facilitar el intercambio de conocimientos e ideas, con el objetivo de promover la confianza del público en este sector.

El Ministro de Comercio, Albert Ísola, comentó: “La Asociación para las Nuevas Tecnologías representa la visión del creciente entorno DLT en Gibraltar y será un componente vital para el crecimiento continuo del sector. Este foro permitirá una mejor alineación de la comunidad blockchain con el sector de los servicios financieros tradicionales [en el Peñón] y proporcionará confianza a las empresas que operan en Gibraltar respecto a nuestro compromiso de colaborar en cuestiones regulatorias y otros puntos relevantes”.

GANT buscará promover estándares elevados de conducta profesional en el sector blockchain de Gibraltar, así como aumentar la reputación del sector financiero de la jurisdicción a nivel internacional. La Asociación colaborará estrechamente con el Gobierno de Gibraltar, la Comisión de Servicios Financieros de Gibraltar (Gibraltar Financial Services Commission) y la Universidad de Gibraltar para asegurar el desarrollo de un sector sólido y sostenible, incluyendo la creación de programas educativos que contribuyan a mejorar el conocimiento acerca de las tecnologías subyacentes que impulsan el sector.

Se aceptarán solicitudes de admisión en GANT por parte de empresas que hayan recibido o solicitado una licencia DLT en Gibraltar, así como empresas de ofertas iniciales de monedas (Initial Coin Offering, ICO), auditores, abogados y consultoras que operen en el sector. El texto de la Constitución incluye toda la información necesaria. La Asociación busca reforzar la sólida relación existente entre el regulador, la Comisión de Servicios Financieros y el Grupo de Trabajo DLT (DLT Working Group) que supervisó el desarrollo del Marco Regulatorio DLT (DLT Regulatory Framework), introducido en enero de este año. Los miembros colaborarán para mantenerse mutuamente informados acerca de políticas futuras y cuestiones regulatorias.

El Presidente (Chairman) designado por la Asociación, David Parody, manifestó: “Se trata de un momento muy interesante para Gibraltar. Estamos viendo el establecimiento de un nuevo sector ahora que la Comisión de Servicios Financieros ha concedido las primeras licencias DLT.

Como Asociación, queremos asegurarnos de establecer un foro efectivo y colaborativo para discutir cuestiones clave. También será nuestra responsabilidad ofrecer caminos eficientes a legisladores y políticos para que puedan dar con soluciones prácticas y efectivas. Del mismo modo, queremos aumentar la base de conocimiento de todo el sector, desde expertos en blockchain a principiantes, por lo cual el esfuerzo educativo será un objetivo clave de la Asociación.”

La reunión inicial de GANT tendrá lugar el martes 29 de noviembre de 2018 a las 10:00 en las instalaciones del Centro Financiero de Gibraltar (Gibraltar Finance), Suite 761 Europort, Gibraltar. Durante la misma, se discutirán la presentación de solicitudes de admisión y formatos de nominación para el comité. Launch of Gibraltar Association for New Technologies Boosts Country's Expanding Blockchain Ecosystem

Blockchain Focused Trade Association will act as a forum for policy makers, regulators, professional firms, and educators

Gibraltar - October 30, 2018 - [HM Government of Gibraltar](#) has today announced the formal launch of the [Gibraltar Association for New Technologies](#) (GANT), a trade association that will aim to drive forward Gibraltar's innovative approach to Distributed Ledger Technology (DLT). The association will establish formal lines of communication between policy makers and the private sector in Gibraltar's fast developing blockchain industry as well as facilitating the exchange of knowledge and ideas, with a view to enhancing public trust in this sector.

The Minister for Commerce, the Hon. Albert Isola MP, commented, "The Gibraltar Association for New Technologies will represent the views of the ever evolving DLT landscape here in Gibraltar and will be a vital component in the continued growth of the sector. This forum will allow the blockchain community to become more closely aligned with the traditional financial services sector here and give confidence to the firms operating in Gibraltar that we are committed to working collaboratively on regulatory and other matters of interest."

GANT will strive to promote high standards of professional conduct within the blockchain sector in Gibraltar as well as further the reputation of the jurisdiction's finance industry on the international stage. They will work closely with HM Government of Gibraltar, the Gibraltar Financial Services Commission and the University of Gibraltar to ensure the development of a strong and sustainable industry, including the delivery of educational programmes that will help advance a core understanding of the underlying technologies supporting the sector.

Applications for membership of GANT will be welcomed from firms who have received or have applied for a DLT licence in Gibraltar, as well as ICO firms, auditors, lawyers, and consultancy firms

servicing these industries, full details can be found in the constitution. The association intends to build on the strong working relationships that exist between the regulator, the Financial Services Commission, and the DLT Working Group that oversaw the development of the DLT Regulatory Framework, introduced in January of this year. Members will collaborate to keep each other apprised of future policy and regulatory matters.

The Association's Chairman designate, David Parody, said, "These are exciting times for Gibraltar. A whole new industry is taking off now that the first DLT licences have been granted by the Financial Services Commission. As an association we want to ensure that we create an effective and collaborative forum for the discussion of key issues. It's also incumbent on us that we provide efficient gateways to policy and decision makers so that practical and effective solutions are arrived at. Similarly, we want to build the knowledge base across the entire sector, from experts to blockchain beginners, which is why educational outreach will be a key objective for the association".

An initial meeting of GANT will be held at Thursday 29th November 2018 at 10:00 at the office of Gibraltar Finance, Suite 761 Europort, Gibraltar, during which the submission of membership application forms and committee nomination forms will be discussed.
